II. Money

A **\$100** non-refundable deposit is required to secure date. The deposit will be put towards your final bill. Deposit will only be refunded if StarMusicDJ cancels engagement.

Remaining balance of agreed performance fee is due **PRIOR** to the start of the event.

If the event is cancelled or the date is changed, the initial deposit is forfeited. An additional \$250 non-refundable deposit will be required to secure new date provided date is available and agreed upon by both parties.

StarMusicDJ accepts money orders, cashier checks, personal checks and cash. There is a \$60 fee for any returned check. If the deposit is paid by check and the bank does not honor the check or the check is returned for insufficient funds, the contract will be deemed void and the date is no longer reserved.

If StarMusicDJ is asked to perform additional time past time requested in contract, an additional amount (cash only) will be charged provided StarMusicDJ agrees.

III. Damages and liability

It is the sole responsibility of the client to secure permission of the host event to allow StarMusicDJ services to be performed.

StarMusicDJ will take the utmost care to produce good sound quality. However, StarMusicDJ will not be held responsible for circumstances beyond our control, including but not limited to power failure, equipment malfunction, fire or other casualty, or client misuse of equipment.

StarMusicDJ reserves the right to terminate contract for any reason at any time. Should StarMusicDJ terminate contract, all monies paid including deposit will be refunded.

Client assume all liability for any form of video or audio copyright infringement. It is the client's sole responsibility to inform StarMusicDJ of any specific needs or changes in events.

In the event any StarMusicDJ equipment is damaged, stolen or destroyed, accidentally or intentionally, by the client, guests, attendants or employees of the client, the client is fully responsible for the equipment's replacement at current new market prices. Client has 14 days to reimburse StarMusicDJ.

StarMusicDJ bears no legal or financial liability to any individual attending event that should be harmed or cause harm to another person or property for whatever reason or cause.

StarMusicDJ plays "clean" (no obscene words) music, however StarMusicDJ is not responsible for song requests made by client and/or guests that have vulgar or "bad" words in the songs.

IV. Outdoor Event Clause

It is understood that if this is a "rain or shine" event. StarMusicDJ is in no way affected by inclement weather. For outdoor events, client shall provide overhead protection in the form of a roof, shelter, tent that is adequate to keep precipitation off StarMusicDJ equipment.

StarMusicDJ reserves the right, in good faith, to stop or cancel the performance should the weather pose a potential danger to StarMusicDJ, equipment or audience. Every effort will be made to continue the performance. However, safety is always paramount. StarMusicDJ compensation will NOT be affected by such cancellation.

V. Requirement of the "client"

Provide a reasonably close parking spot for unloading and loading of StarMusicDJ equipment - at least 2 hours prior to performance and 1 hour following performance.

Provide at least 2 grounded wall plugs for electricity withing 20' of StarMusicDJ setup.

Client will provide adequate security before, during and after the performance.

VI. Sound and Lighting

StarMusicDJ shall furnish all sound equipment, microphones, lighting and power strips necessary for performance.

The client may submit a list of requested songs, but, there is no guarantee that StarMusicDJ will play every song on client's request list. Any "must play" music must be provided in advance in mp3 or wav format.
